CRIMINAL COMPLAINT

The undersigned, under penalty of perjury, complains and says that on or about 10/9/2024 10:20:55 PM, in the County of Bernalillo, State of New Mexico, the above-named defendant(s) did commit the above Offense(s) (here state the essential facts):

On October 9, 2024, I was tasked with being a case agent reference a child solicitation case.

On or around October 5, 2024, a sworn and certified Santa Fe PD Detective, posed as an O.C.E (online covert employee). The O.C.E. posed as a "bad dad" on the website FetLife. FetLife is a social networking platform where people can meet who like BDSM, kink, and fetishes.

On October 9, 2024 at approximately 1955 hours, Samantha Clark advised the O.C.E. that she was going to be en route to the disclosed location to meet with the "bad dad" and his cub. The cub was described as a 12YO female.

Samantha Clark messaged the O.C.E. on FetLife indicating she was interested in her ad that was promoting family play. She messaged under username "snookyapplehead". Samantha messaged them and indicated she was interested in meeting them, however, she stated she was a "little on the wild side". She was advised by the O.C.E. that they were a "daddy" and they had a "cub of their own". The O.C.E. advised that the "little" was really young and advised that she is a 12YO and a female. After advised Samantha that the "cub" was 12YO and "young", she advised, "I like fisting. That's the most extreme I would say could happen right away. But I like everything forced. That's what turns me on." They ask if she wants the "little" to fist her or if she is going to fist the "little". Samantha responds with, "That I don't know. Probably me fist her!" Based on my training, knowledge, and experience, I know the term fisting to be associated with a sexual act where a fist is inserted into the genital orifice of a person.

Samantha advised she needed a ride after meeting up. The O.C.E. advised they could give her a ride after they meet. Samantha told them she needed to call an uber to arrive at the location. The address was provided, and Samantha ordered an Uber scheduled to pick her up at 2030 hours.

At approximately 2110 hours, Samantha arrived in an unknown car. She advised it was an Uber. Samantha was detained. In an excited utterance she told me I did not look like a "papa". I read Samantha her rights pursuant to Miranda and she advised she understood. She told me she has a kink

fetish where she likes to be dominated. She explained she arrived at the house to meet with a "dominant" who had a "cub" with the intentions of "getting her ass beat". She initially told me they told her the "little" / "cub" was 14YO then changed it to 12YO. She said in the fetish world and on FetLife, people often say they are young kids to fulfill a fetish they have. She said even though they say they are young, there has never actually been a child present, but rather it is role playing. Samantha acknowledged that they told her she was meeting with a "little" who was 12YO, however, she stated she believed they were an adult. She advised she did not want to have sex because she has a virus, but the most she told them she would do was fisting. She said the only reason she was meeting was for a ride home, however, she advised she has been messaging this person for a couple days. It is unknown why she waited a couple days to ask for a ride rather than the first day.

Based on the above, Samantha Clark ordered an Uber with the intentions of arriving at the location to meet with a "dominant" and a "little". After being advised that the little was 12YO, a juvenile, she advised she would "fist" the little, a sexual act.

Samantha Clark, named defendant in the City of Albuquerque, Bernalillo County, State of New Mexico, knowingly and intentionally solicited, a child at less than thirteen years of age, by means of an electronic communication device to engage in sexual intercourse, sexual contact, a sexual or obscene performance, or any other sexual conduct and the defendant was at least four years older than the child pursuant to the solicitation, contrary to NMSA 1978, Section 30-37-3.2. Samantha intended to commit criminal sexual penetration of a 12YO child contrary to NMSA 1978, Section 30-9-11D(1). Additionally, Samantha attempted to commit a felony contrary to NMSA 30-28-1A and sexual exploitation of children by prostitution contrary to NMSA 30-6A-4.

Contrary to Section(s) 30-37-3.2 - CHILD SOLICITATION BY COMPUTER 30-9-11D - CSP 1ST DEG 11A
SEX ORGAN M F ONLY 30-28-1A - ATTEMPT TO COMMIT A FELONY 1ST DEGREE 30-6A-4B -
SEXUAL EXPL. CHILD PROSTITUTION HIRE UNDER 16YOA NMSA
1978.
