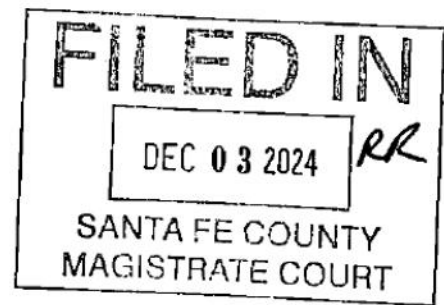

### STATEMENT OF PROBABLE CAUSE

The State requests the above defendant be noticed in for arraignment for the following reasons (set forth a plain, concise and definitive statement of the facts establishing probable cause):

The defendant was employed with Community Options, Inc., a Developmental Disabilities Waiver group home located in Santa Fe, New Mexico as a caregiver. The defendant completed numerous training courses on how to care for residents of the group home, including individual specific training. Many of the training courses had pages acknowledging receipt of the documents and training; the defendant signed those documents admitting he received the training. Some of the titles of the training the defendant received are: "Understanding Emerge," "Ethics and Professionalism," and "Code of Ethics."

Two videos recorded on May 11, 2024, show the defendant forcefully grab and push the neck of P.C. towards the table, he also forcefully pushed P.C.'s wheelchair into the table and then aggressively grabbed P.C.'s upper body in a bear hug type grab and pushed it onto the table he was sitting in front of. In one of the videos, you can hear the defendant tell P.C. "No one is going to take you the bathroom fool. No one. No one." In that same video, a couple seconds later you can hear the defendant tell P.C. to "play with your toys fool, no bathroom."

A review of the defendant's personnel file shows the defendant was on the clock, working, for Community Options, Inc. at the Camino Esquina group home on May 11, 2024; schedules recording the number of hours worked and a check stub confirm the defendant was paid for working that day.

The person who recorded the incidents was interviewed and confirmed the defendant physically abused the resident on Saturday May 11, 2024, while the resident was at the Community Options, Inc. Developmental Disabilities Waiver group home located in Santa Fe, New Mexico.
